Each registrant will receive a marching order on a **parade lineup card** sent by U.S. Mail by **December 7**. Lineup will begin at 7:00 a.m. on December 10, 2011 in front of the Morehead Planetarium. All units must be present by 8:00 a.m.

Get your group organized early and you will be ready for the parade! We look forward to seeing all of you on December 10, 2011. Thank you for your commitment to this hometown parade.

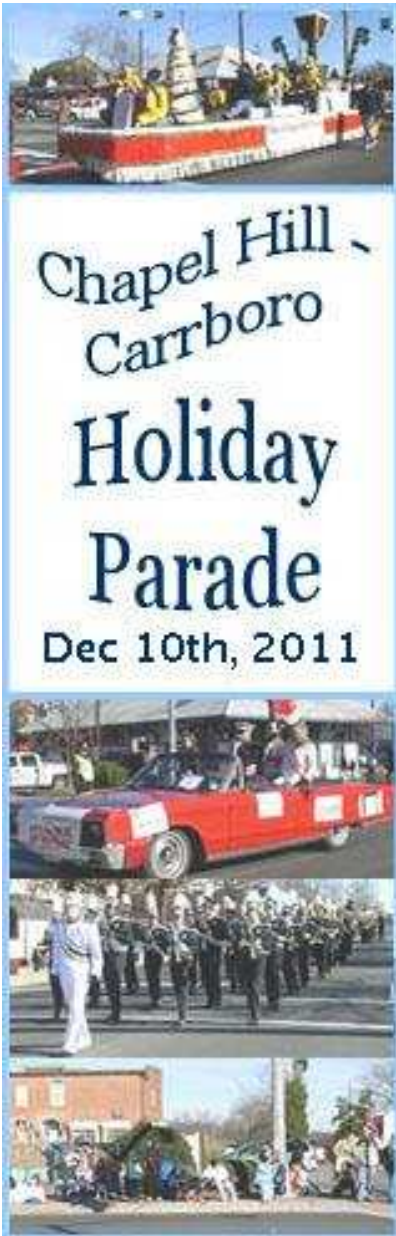
